TEMM 15

The three countries have strengthened efforts in forging a deeper partnership in the area of environmental protection to jointly cope with climate change in the region and the world. The 15th Tripartite Environment Ministers Meeting (TEMM15) was held in Kitakyushu, Japan in May, 2013. The Ministers shared information on the progress made in each country regarding their respectice environmental policies after TEMM14 and signed the Joint Communiqué of the 15th Tripartite Environment Ministers Meeting among China, Japan and Korea. They also welcomed the award ceremony held to commend individuals who contributed to environmental cooperation among the three countries, based on the agreement at TEMM14, and expressed their appreciation to the awardees.

CJK FTA

One major progress was witnessed with the CJK FTA. After seven years of joint academic study (2003-2009) and two years of joint study among government officials, business representatives and academia (2010-2011), the three countries announced the launch of the CJK FTA negotiations on the occasion of the 21st ASEAN summit and related summits held in Phnom Penh, Cambodia in November, 2012.

Following the official announcement, the three countries conducted the first and second round of the CJK FTA negotiations in Seoul, March 2013 and Shanghai, August 2013 respectively, setting up the foundation for a series of negotiations to follow in the future.

During FY 2012-2013, providing support for trilateral mechanisms has remained a top priority for the TCS. In this regard, the TCS' role is largely divided into two categories: the provision of logistical support (set-up of a meeting venue) and substantive support (preparation of summary records). On the logistical side, the TCS assists in protocol arrangements of a meeting venue and registration of participants. Alongside such administrative duties, the TCS assists in more substantive aspects of meetings by drafting and disseminating minutes or preparing relevant cooperation proposals. Going forward, the TCS will continue to expand its efforts to serve as the focal point for coordinating of key trilateral meetings and consultations, thereby ensuring timely and effective communication amongst the Three Parties.

Following the 1st Trilateral Agricultural Ministers' Meeting (TAMM) in April 2012, the three countries held the Expert Meeting for Preparation of the 2nd TAMM in Tokyo, Japan in December 2012. At the request of the three delegations, the TCS participated in the discussion and helped to update the TAMM agenda items such as food security, responding to plant and animal infectious disease, natural disasters, researcher exchange, economic partnership, and global and regional cooperation. The TCS drafted the minutes which were endorsed by the Meeting and then circulated to the three Ministries. The three Ministries expressed expectation for the TCS's engagement in the future development of trilateral agricultural cooperation.

4. EAST-ASIA EARTHQUAKE SEMINAR 2012 The East-Asia Earthquake Seminar 2012 was held from October 29 to 31, 2012 in Jeju, ROK, hosted by the Korea Meteorological Administration and participated by Japan Meteorological Agency and China Earthquake Administration.

Deputy Secretary-General Mao Ning participated in the seminar on October 29, 2012 and gave congratulatory remarks during the opening ceremony, emphasizing that strengthening cooperation in the disaster management field plays a significant role in constructing a more solid and fundamental cooperation structure among the three countries. Approximately 80 researchers and scientists from the three countries as well as other countries participated in the seminar. During the seminar, the participants presented their research results and discussed issues related to disasters induced by earthquakes, tsunamis, and volcanic eruptions from a scientific perspective.

FY 2012-13 has been an exciting and productive year for the TCS as the initiatives planned in the previous year have borne fruit. One such example is the Trilateral Table Top Exercise (TTX), which was successfully organized by the TCS as a follow up to the three leaders' commitment made at the 4th Trilateral Summit in 2011. The TCS also contributed to one of the major cooperative agendas for the three countries— Trilateral FTA promotion — by hosting the Trilateral Business Networking Reception in Seoul and CJK FTA Seminar in China. Another significant development marking FY 2012-13 was the launch of a series of youth-oriented projects such as the Trilateral Video/Presentation Contest and the Young Ambassador Program. Through such youth programs, the TCS created unique opportunities for the next generation of leaders in the three countries to foster mutual understanding while developing leadership skills.

1. TTX ON DISASTER MANAGEMENT

In response to the leaders' commitment at the 4th Trilateral Summit held in Japan 2011, the TCS organized and facilitated this one-day exercise on March 14, 2013. This exercise brought together disaster management officials from the relevant ministries of the three countries including the Ministry of Foreign Affairs (MOFA) of the Republic of Korea, National Emergency Management Agency (NEMA), and Korea Meteorological Administration(KMA); Ministry of Foreign Affairs of Japan, Cabinet Office of Japan, and Japan International Cooperation Agency (JICA); Ministry of Foreign Affairs and Ministry of Civil Affairs of the People's Republic of China.

The participants of the three countries shared the view that the TTX provided a meaningful and useful platform to increase mutual understanding of the procedures and mechanisms with respect to humanitarian assistance on disaster relief in the three countries. They also agreed to hold another Trilateral TTX next year, with a vision to continue strengthening trilateral cooperation in the field of disaster management.

The conclusions and recommendations from the exercise were summarized in the Report of the First Trilateral Table Top Exercise, which was then submitted to the three governments and distributed to relevant agencies and ministries.

Following the 1st round of FTA negotiations among China, Japan and the ROK in March 2013, and by the directives of the three governments, the TCS hosted the CJK FTA Seminar on June 18, 2013 in Weihai, China in collaboration with Weihai Municipal Government and with media support from China Daily. The event gathered over 100 government officials, scholars and business representatives of the three countries. The participants reflected on the progress of the CJK FTA, explored its significance with trilateral cooperation as well as regional implications, and shared views on prospects and challenges for its future establishment. Mr. Yu Jianhua, Vice Minister of Commerce of China delivered the keynote speech. Mr. Woo Taehee, Assistant Minister for Trade, Ministry of Trade, Industry and Energy of the ROK gave the congratulatory remarks. Mr. Sun Shutao, the Secretary of the Weihai Municipal CPC Committee spoke on behalf of the local government. In his opening remarks, Secretary-General Shin Bong-kil expressed belief in the resilience of the trilateral cooperation to

3. TRILATERAL BUSINESS NETWORKING RECEPTION

In November 2012, trade ministers of the three countries announced the launch of the CJK FTA negotiations. To commemorate this official announcement and to facilitate closer ties among business groups of the three countries, the TCS hosted the Trilateral Business Networking Reception in Seoul, ROK on January 17, 2013. The reception was co-sponsored by the Korea International Trade Association (KITA), Seoul Japan Club (SJC) and Chinese Chamber of Commerce in Korea (CCCK). Mr. Bark Tae-ho, the then ROK Trade Minister highlighted in his remarks that the presence of the TCS had shown the feasibility of the vision towards economic integration in Northeast Asia. Mr. Ahn Hong-joon, Chairman of the Foreign Affairs, Trade and Unification Committee of the ROK National Assembly, emphasized in his congratulatory remarks that 'friendship' and 'compromise' among the three countries are the key to the early establishment of the CJK FTA. The representatives of the three business groups, Mr. Moon Hi-chung, Vice Chairman of KITA; Mr. Kobayashi Tadashi, Chairman of SJC; and Mr. Huang De, President of CCCK attended the reception and affirmed their expectations for the CJK FTA. Over 200 business people from the three countries participated in the reception.

Upon successful conclusion of the reception, the TCS has been bent on the creation of trilateral business networks among the three countries, and plans to hold similar events in Beijing and Tokyo in the future.

The TCS organized the "Trilateral New Wave: University Student Short Video and Multimedia Presentation Contest" from March to July 2013 with the aim to enlarge the network of friendship among the youth of the three countries as well as to disseminate positive images about the future of the trilateral cooperation. About 40 teams consisting of more than 170 students participated in the Contest. Each team was composed of 3 to 5 full-time university students of all the three nationals. Beijing and Tokyo rounds were organized by the TCS and were held in June 2013 in China and Japan, respectively, and the Seoul round was held as "Trilateral Campus Harmony" on May 2013 by Korea-China Friendship Association. The Final Round was held on July 5, 2013 in Seoul, ROK. The event brought together more than 150 participants including students, professors, and government officials from the three countries. The TCS will continue to hold this event every year and develop it into a prominent and widely-recognized video and multimedia festival among the youth of the three countries.





5. YOUNG AMBASSADOR PROGRAM(YAP)

The TCS hosted the 1st Trilateral Young Ambassador Summer Internship Program (YAP) in Seoul from July 8 to August 16, 2013. The YAP is a six-week summer internship program that offers professional training and on-site visits for young people from the three countries to develop the understanding of the trilateral cooperation. The YAP interns are involved in on-job trainings and various projects and assist TCS's functional departments.

This year, the YAP has received more than 600 applications from Korea, China and Japan, and selected 27 students from the three countries to join the program. The TCS intends to hold the YAP on a regular basis in the future in order to promote the trilateral cooperation and foster the sense of friendship among the youth of the three countries.

In an effort to further raise its profile and visibility, the TCS has undertaken a series of promotional activities throughout the year. In particular, following the success of the International Forum for Trilateral Cooperation (IFTC) 2011, IFTC 2012 was held with active participation of leading opinion and policy makers of the three countries. Outreach has also been central to TCS activities. Whether through face-to-face meetings /on-site visits or conference participation or interviews/speeches, the TCS has endeavored to engage a diverse spectrum of individuals and organizations with a view to spreading the vision of trilateral cooperation. In the same vein, the TCS has welcomed many visitors to its office, where they learned about the mission and activities of the TCS.

On the occasion of the 1st anniversary of its establishment, the TCS held the International Forum for the Trilateral Cooperation under the theme of "2012: Year of Transition and the Trilateral Cooperation" at the Shilla Hotel, Seoul, ROK on October 15, 2012.

Secretary-General Shin Bong-kil announced the opening of the forum and introduced the TCS's efforts for the promotion of the cooperative relationship among the three countries in the past year. The forum featured key dignitaries from the three countries such as Mr. Kim Sung-hwan, then Foreign Minister of the ROK; Mr. Nakagawa Masaharu, Former Minister of Education, Culture, Sports, Science and Technology of Japan, and Mr. Lu Shumin, Vice President of Chinese People's Institute of Foreign Affairs. All the dignitaries, recognizing complex and fluid situation in Northeast Asia, stressed the increasing importance of strengthening the trilateral cooperation. They expressed expectation for the TCS to play professional and creative roles for the promotion of the trilateral cooperation.

In the following four sessions, i.e., "Northeast Asia in Times of Transition", "Strengthening Economic Cooperation and Integration", "Specific Proposals-Expanding the Horizon of the Trilateral Cooperation" and "The Role of the TCS", 15 speakers from academic, business, media and civil society sectors of the three countries gave presentations and shared wisdoms on a variety of topics, such as political strategic thoughts for the future Northeast Asia, CJK FTA, finance and industry cooperation, cyber-nationalism and people-to-people exchange and the role of the civil society. They also offered suggestions on the future development of the TCS.

Mr. Halldór Ásgrímsson, the Secretary-General of the Nordic Council of Ministers and Former Prime Minister of Iceland, delivered a luncheon speech and shared the five Nordic countries' experience of co-prosperity.

After the Forum, the TCS held its 1st Anniversary Reception, in which then ROK presidential candidates Ms. Park Geun-hye and Mr. Ahn Cheol-soo delivered congratulatory remarks.

2. CJK FTA EXHIBITION

For the promotion of the CJK FTA among the general public, the TCS staged the "Trilateral FTA: Win-Win" exhibition on the occasions of the Trilateral Business Networking Reception in Seoul, ROK, and the CJK FTA Seminar in Weihai, China. The exhibition came in English-Korean then English-Chinese versions. It was the first time to give a comprehensive, concise and systematic narration on the CJK FTA. The chapters of the exhibition included "Close Economic Partners", "Solid Foundation", "Great Potential", "FTA Research and Preparation", "Possible Contents of Trilateral FTA", "Bright Future" and "Roles of the TCS". The exhibition specified that the CJK FTA would facilitate further economic integration, increase competitiveness of the manufacturing industries, and expand trade in services as well as trilateral investment flows among the three countries. It spelled out challenges in sensitive sectors of agriculture and fishery, manufacturing and services industries. It emphasized that the CJK FTA would cover 21.8% of the world's population and 20.4% of world's GDP, and constitute a building block of further economic integration in East Asia. On each of the occasions, the exhibition received wide applause from over 100 audience from the government, business, academia and media sectors.





3. TCS OPEN HOUSE 2013

The "TCS Open House 2013" was convened on May 16, 2013, with the aim of introducing the office and promoting trilateral cooperation to the general public. Alongside traditional tea ceremonies of the three countries, a photo exhibition was held to showcase the progress of TCS throughout the year and videos on the three countries' culture and tradition. More than 100 participants enjoyed the tea ceremonies of the three countries carried out by Korean Tea Culture Association, Japanese Urasenke Seoul Branch and Chinese Tae Tea Group respectively. While tasting three different kinds of tea, they also actively participated in quiz sessions related to the TCS and trilateral cooperation, as well as in a lucky draw. For the past two years, the TCS Open House has drawn much attention and received positive feedback from the media and public of the three countries. Through interactive sessions featuring the colorful culture of the three countries, it has helped the TCS and trilateral cooperation gain wider recognition among the general public and provided a platform that encourages the sharing of knowledge regarding the future of trilateral cooperation and the TCS. It has become a flagship cultural event organized by the TCS.



Secretary-General Shin Bong-Kil Visited China (Beijing and Yangzhou, April 24-26, 2013)



Secretary-General Shin elaborated on the implications of the CJK FTA to the economic integration in East Asia, i.e., 1) the three countries are major stake-holders in shaping the regional production network; 2) they could be path-finders for the regional economic integration; and 3) they might showcase the complementary development of multi-integration frameworks in the region. 



UNITED NATIONS ECONOMIC AND SOCIAL COMMISSION FOR ASIA AND THE PACIFIC (UNESCAP)

In 2013, the TCS collaborated with the UN ESCAP-ENEA (East and North-East Asia Office) on a regional cooperation monitoring project by contributing the outcome of TCS's 2013 Trilateral Economic Research. This constituted the TCS's first successful case of concrete collaboration with other international organizations. The TCS and the UN ESCAP taskforces consulted and made necessary alignment on the agenda, tasking, scheduling and financing of the researches. The TCS team participated in the Expert Group Meeting on Regional Indicators for Monitoring Regional Cooperation and Integration in East and North-East Asia held in Incheon, ROK in July 2013, and shared research data as well as findings.

During FY 2012-13, the TCS has continued to expand its efforts to become an "information hub" by producing a range of publications and reports including the 2012-13 Progress Report of the Trilateral Cooperation. With cooperation and support from the relevant ministries and agencies, the TCS compiled the 2012-2013 Progress Report of the Trilateral Cooperation. The report contains an overview of ongoing cooperation efforts across the board.



2. GENERAL INTRODUCTION TO TRILATERAL ECONOMIC RELATIONS


The TCS is tasked to conduct research on and promote understanding of the trilateral cooperation. As a token of such efforts, the TCS compiled a concise and easy-to-read booklet on the economic relations among the three countries on basis of the TCS' trilateral economic research project in 2011-2012. The booklet provides a quick reference to the basic economic features of the three countries in areas such as international trade, investment, finance, people-to-people exchange and future economic integration. Readers will take a glance of the strong economic ties among the three countries as well as the great potential trilateral economic cooperation. The booklet has been circulated to the three governments as well as the general public.



3. TRILATERAL STATISTICS BOOKLET


The TCS published the 2012 Trilateral Statistics in November 2012, with the aim of giving a neutral and comprehensive insight into the current economic outlook and interrelations of the three countries. It carries major economic indicators including trade and investment, finance, natural resources, transport and logistics, information technology as well as demography, which have been sourced from national and international agencies. This 182-page booklet has received welcome especially among the government and academia sectors.





4. TRILATERAL ECONOMIC RESEARCH PROJECT IN 2013

The TCS conducted the Trilateral Economic Research Project to follow up on the economic development and integration among the three countries on a yearly basis. This annual research project explores timely subjects in terms of regional perspective and accumulates chronological overview of economic performance in the three countries. Prof. Abe Kazutomo of Tokyo Denki University, who participated in the Joint Academic Research on Trilateral FTA, took charge of the project under the sponsorship of the TCS. While the 2012 research covered the decade span, this year's research focused on short-term description and analysis in order to capture the current status of trilateral economic relations. The outcome of the research has also been incorporated into the regional cooperation monitoring project of the UNESCAP.



5. INTO THE THREE COUNTRIES: A HANDBOOK ABOUT CHINA, JAPAN, AND KOREA

The TCS produced its very first handbook, "Into the Three Countries: A Handbook about China, Japan, and Korea" to promote the public's understanding regarding the three countries. The book consists of "General Information" and "Life Style"; it was created for people who want to learn unique facts as well as general information about the three countries, while also highlighting beautiful pictures and statistic information. It provides the reader with the similarities and differences of each country, in both traditional and modern contexts.



6. TRILATERAL TTX REPORT

The TCS published the Report of the Trilateral TTX, which contains a set of conclusions and recommendations from the exercise. Copies of the Report were distributed to relevant disaster management agencies as well as the public of the three countries, with an aim to promote mutual understanding of disaster management practices and policies of each of the three countries.



1. ORGANIZATION

The Trilateral Cooperation Secretariat (TCS) was established as an international organization in September, 2011 in Seoul. The vision of the TCS is to promote peace and common prosperity among China, Japan, and the Republic of Korea. The TCS consists of a Consultative Board and four Departments. The Consultative Board, the executive decision-making body of the organization, is comprised of a Secretary-General and two Deputy Secretary-Generals. The Secretary-General is appointed on a two-year rotational basis in the order of the ROK, Japan, and China. Each country other than the one of the Secretary-General nominates a Deputy Secretary-General respectively. Under the Consultative Board, there are four Departments of Political Affairs, Economic Affairs, Social-Cultural Affairs, and Management. The four Departments are composed of diplomats seconded by the three countries, and General Services Staff recruited through open competition from the three countries.



- 3. Explore and identify potential cooperative projects among the three countries, and report those projects to the relevant consultative mechanisms for adoption;
- 4. Evaluate the cooperative projects and draft reports on them, compile necessary documents into database, and submit annual progress reports to the Trilateral Foreign Ministers' Meeting for approval; and
- 5. Conduct research on important issues related to the trilateral cooperation, manage the TCS' website, and promote understanding of the trilateral cooperation.
